PROPOSED SIMPLE FAIR TABS SYSTEM

1. Flat Base Fee:

\$25 per year for all passenger vehicles.

2. Value-Based Add-On:

1% of vehicle value

Minimum: \$50

Maximum: \$225

3. Age Discount:

Vehicles 10+ years old: 40% off total

Vehicles 15+ years old: 60% off total

4. Electric Vehicles (EVs):

EVs pay a flat \$75 annual road-use fee in place of special surcharges.
